OLD BUSINESS:

- Gordon Boyce- Comm. Reid spoke with the Department of Environment about the well de-commissioning regulations and was referred back to the guidelines. He also spoke to DJ well drilling and if we do our own excavation the cost would be around \$2300, putting the total cost of de-commissioning around \$3000. The Village will still have to decide about the option to purchase the land, the land owner may be willing to sell it to the Village for the assessed value (\$5100). As the SWPP has a mandate to protect the water shed area we will contact the SWPP Chair and setup a meeting with the committee. We should also look at getting data from the well.
- Bradford Poole Driveway-Mr. Poole did not end up purchasing the property so this will not be moving forward.

PW Committee:

- LCHC- Painting upstairs is complete. Ben will be ordering electrical covers & lights. Vinyl floor has been installed in the bathroom. The pharmacy area is primed and ready for them to take over.
- LCDC- Still some students leaving & closing out accounts, but have also had a few new members join. Richard had to climb up the tower to re-fasten some connectors. Tower 4 brackets have come back from Waldon Banks. Brad Pool will be hauling some coarse rock up to the top of the road so we can start getting the base for Tower 4 ready. We will need to re-submit our permit to the County. This tower will be cost shared between water & wastewater.

We have a quote from Howard Little and are awaiting a quote from Dexters. We have applied for our grant from the County (\$10,000) and the remainder will come from the sidewalk reserve.
- 2. Vacations- Tim will be off June 18. Jeff will be off July 1-3, Melissa will be off July 6 & 9 as well as August 24-27.
- 3. Backhoe- Still looking for a new to us backhoe, our budget is around \$80,000 and we would like 2015 or newer and with less than 2000 hours.

4. Website- Needs to be upgraded. Comm. Reid is recommending we move to a wordpress server. Scott is willing to take this on. Is the Commission willing to authorize Scott to do this work (approx. 10-20hrs)

Comm. Gaudet made a motion to approve Scott for up to 20hrs of work on the website. Seconded by Comm. Baskwill. Motion carried.
