Superintendent Report for: July 2021

- Water Utility Test reports: All test reports have come back within acceptable limits. Annual well head samples will be taken tomorrow for microbiology. Manganese samples taken as well and results came back within acceptable limits.
- Waste Water Test Reports: Quarterly WW test have not been completed for this 3rd quarter.

3. Water Utility Infrastructure:

- a. Current overnight flows are at 0 GPM again.
- b. 1st quarter water meter readings completed, no inoperative meters this quarter.
 1 still outstanding from last quarter.
- c. Water meter installed at the cemetery and water off due to leaks on their side of the lateral. Repairs are under the way today and water will remain off until repairs are completed.
- d. Swimming Pool and Ballfield meters have been installed and leaks have been repaired.
- e. Water meter installed at 75 Prince Street.
- f. Minor water leaks repaired by village residents at various locations,

4. Waste Water Utility Infrastructure:

- Regular maintenance at the UV building to keep the UV lighting system working at its current optimal level.
- b. Maintenance on Blowers at WWTP.
- c. Grass has been cut at the WWTP, & the banks around the lagoons have started to be cut and will be completed in the next couple weeks.

5. Facilities:

a. All facilities are in good working order.

6. Village Equipment:

a. All the Ford Ranger body work has been completed and is now ready for MVI which will occur on August 3rd. Both front fenders have been replaced and the box was rebuilt. As well as all mounting areas that had deteriorated.

- b. New Holland tractor was sent out for an air conditioning recharge as the refrigerant level was low. A list of parts that will need to be replaced has been submitted for quoting to Tidal Tractor and I have received the quote on upcoming parts repairs.
- c. Oil changes performed on New Holland and Topkick.
- d. All other equipment is in good working order.

7. Sidewalks and Streets and Grass

- a. Garbage has been picked up from cans & around the village.
- b. Grass has been cut around town, at village infrastructure near boat launch, and around WW lift stations when the weather has been permitting. Grass around village hydrants is due for trimming.
- c. Grass cut at the swimming pool before opening.
- d. Topsoil has been laid at the Library to fill in the ditch where the electrical was run last fall. Area has been seeded as well.
