Physician recruitment policy I mentioned last month is back and set to include Lawrencetown

New By-Law is up for first reading. S4 Local Improvement Charges By-Law. Primarily this by-law allows the county to charge landowners for new services that come to their lot.

The report is back from the Warden versus Mayor survey, which favors the mayor system. The more interesting part of it I noted was that there is no preference in the results under the warden system for the number of councillors but under the mayor system, there is a strong preference for the fewest number of councillors.
